### Training Course on “Postal Financial Services, Electronic Services and Letter Post Service” in Jordan



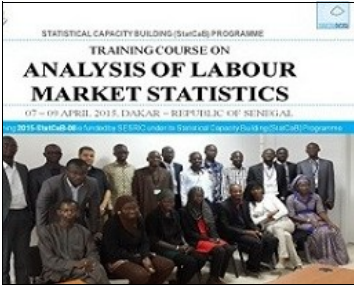

## Training Course on “Institutional Sectors” in Togo



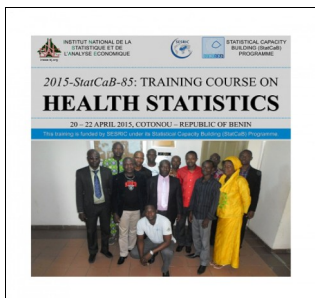
