



BASIC QUESTIONNAIRE PROPOSED BY WTO TO ESTIMATE VISITOR EXPENDITURE ASSOCIATED TO INBOUND TOURISM

PRESENTATION

As explained in the next section III.3 "General guidelines for its implementation", the questionnaire proposed by WTO should be used as a starting point in those countries that consider useful to develop a research that will allow the direct evaluation of visitor expenditure associated to inbound tourism. We understand the answers given will not only contribute to improve the analysis of the economic impact of tourism in the country of reference and its different regions, but will also allow a better international comparability of this basic variable for the economic analysis of tourism.

The final questionnaire should take into account the tourist reality of the country of reference (it is recommended to adapt this proposal to the corresponding national circumstances) and should also guarantee that the data obtained can be used not only by the National Tourism Authority, but also the Central Bank and the National Statistical Office.

Both this questionnaire and the general guidelines for its implementation compose this WTO proposal, which has been made possible thanks to the execution of the research on international experiences in measuring visitor expenditures, co financed by the Canadian Tourism Commission, the Instituto de Estudios Turísticos (Spain), the Swedish Tourist Authority and the World Tourism Organization. The starting point used was the general framework resulting from the comparative analysis obtained from the questionnaires used by the eight countries that have accepted to cooperate in this project (Canada, United States of America, Mexico, Spain, France, Italy, Sweden and Finland). From there, the Department of Statistics and Economic Measurement of Tourism has presented different drafts that have been modified following the comments and suggestions of all those technicians mentioned in section III.2.

Some characteristics of the questionnaire should be pointed out from the beginning to guarantee a good interpretation:

- the questionnaire is an interviewer-administrated exercise that should be implemented in a significant sample of the country entry-points. Therefore, the survey designed is a border survey type.
- those selected visitors will fill it in on a voluntary basis and the answers will be confidential.
- it should be used when the visitor leaves the country; this will be easier when those visitors leave the country by other means of transportation than by road.
- finally, the consultant firm that has carried out the research has elaborated the questionnaire design, using its own methodology. To avoid any confusion, the following example illustrates how to go through the questionnaire:
