Global assessment of the national statistical system of the Kyrgyz Republic

- 2011** Three assessment missions of experts from UNECE, EFTA and Eurostat;
- 24 January 2012** Report on Global Assessment was published on UNECE web-site, presented for representatives from President and Government Offices of the Kyrgyz Republic, public authorities, NGOs, donor-countries, as well as for experts from international statistical and economical organizations;
- 2013** Strategy of Development of Statistics of the Kyrgyz Republic for 2013-2017



Main recommendations of Global Assessment

- Improvement of the Law on State Statistics in accordance with UN Fundamental Principles;
- Modernization of statistical production processes;
- Development of Communication and Marketing Strategy;
- Getting access to all administrative data;
- Quality of statistical data in accordance with international standards and recommendation

Within the implementation of Component 1 of World Bank project

With advisory support of international experts (Twinning partnership under Destatis)



Strengthening of technological capacity, update and expand of statistical infrastructure

- **Update computers, servers, office and printing equipment;**
- **Establish the unified republican corporate network on the base of VPN channels (Intranet-Statistics)**
- **Development and implementation of the automated information and statistical system “E-reporting”**



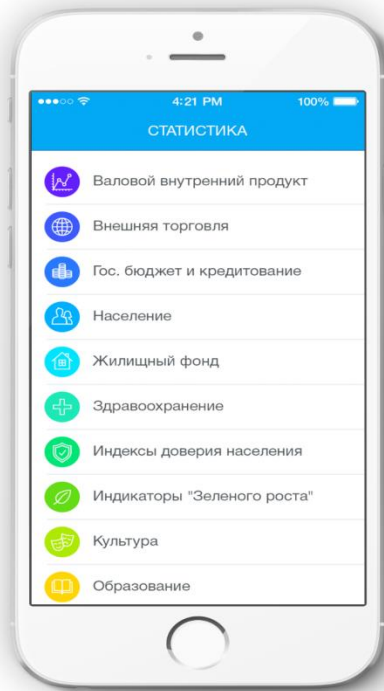
Development of communication and marketing strategy

Conduction of regular press-conferences and meetings of press-clubs for mass media

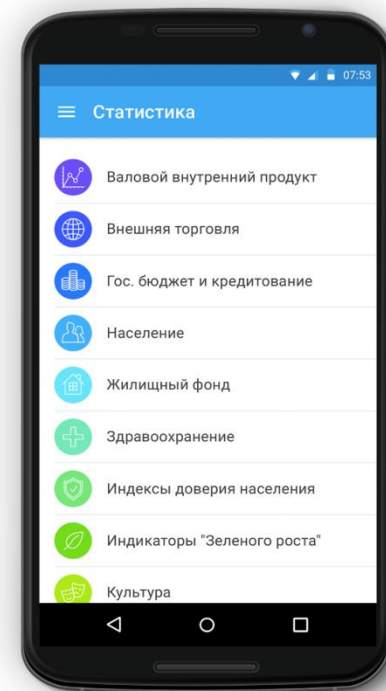

Digital transformation program of the Kyrgyz Republic (“Taza Koom”)

- Establishment of the system of electronic interagency communication;**
- Safety data exchange in electronic format;**
- Compatibility of departmental (agencies) information systems at the technical and technological level on the base of common standards and classifications**



Statistical data quality management

Kyrgyz-Norwegian project, component “Organizational development”:

- Use of General statistical business processes model (GSBPM);

- Systematization of documentation and its connection with GSBPM;

- Introduction of quality assessment into the practice of NSC KR according to European Statistics Code of Practice.





Modernization of data production

- Introduction of SNA 2008
- Improvement of statistical data production
- Improvement of methods of collection, processing and organization of statistical observation of the activity of entrepreneurship entities
- Strengthening of organization capacity of the national statistical system
- Strengthening of statistical registers
