WELCOME SPEECH Dr. Savaş Alpay Director General, SESRIC

Bismillahirrahmanirrahim,

Distinguished Representatives of the National Statistical Offices of OIC Member Countries, OIC Institutions and the International Organisations,

It gives me great pleasure to welcome you all to Izmir on the occasion of the Second Session of the OIC-StatCom. I would like to express our sincere thanks and appreciation to the Islamic Development Bank for their effective cooperation in the organisation of this important meeting. I am very happy and proud that the meetings of the National Statistical Offices of OIC Member Countries are becoming more structured and the OIC Statistical Commission is attracting more and more Member Countries to these meetings. This year, we have a record number of attendance: More than forty countries are present in the hall and this is a great success. I also thank you for making this event possible in such a high level.

Of course, we are expecting a lot of outputs from these meetings; so we are particularly, through the OIC-StatCom, aiming to enhance the statistical competencies of our Member Countries and also to generate opportunities to make higher contributions to the global statistical system. We know that the statistical capacities of our Member Countries vary dramatically from one country to another and the statistical capacities have a heterogeneous structure. Some of the member countries have very high level of operations; cutting edge technologies in their processes; but in some other, particularly in the least developed member countries, the situation is not as good. Therefore, this requires strong cooperation among the Member Countries.

In fact, this observation was noticed by SESRIC in 2007 and we started our capacity building programmes to make the change of expertise and experience among the Member Countries possible. Since 2007, you all know that we are sending out surveys to identify the needs and capacities of our Member Countries in different areas under statistics and up to now, many capacity building programmes have been implemented with your cooperation and with the participation of the experts from our NSOs. I am very pleased that hundreds of experts in National Statistical Offices have been trained through these programmes. We have also a very strong cooperation with different international organisations such as EUROSTAT, UNESCWA and

others in this area. Of course, this is not enough, we will continue to increase

our cooperation, our capacity building activities and OIC Statistical

Commission will be also another means to achieve this in a more structured

manner.

most people go to Google instead of coming to our websites to make use of

statistics produced by us. Why is it so? Because the visual technologies they

use are so attractive and people would like to make use of them. You all

know that it initially started with Gapminder Foundation's software of

Sweden that was very attractive, then it was acquired by Google, and now,

under Google, we have Google Motion Charts.

Last year, I mentioned that we are making our best to bring the cutting edge technologies to our Member Countries, so in that regard, at the moment we have in our website, SESRIC Motions Charts which uses a similar technology like Google. I am pleased to inform you all that our engineers have developed open source software, which has the capacity to do the functions done by the Google Motion Charts. In fact, it is, in some cases, doing some better functions as compared with the Google Motions Charts. This new module being developed by our own engineers is in three languages: in English, Arabic and French. So now, the model is almost finished and we will be very pleased to give them to you free. This programme will be given to you all free. You can install this programme in your website and you can use this programme. We will of course give you the technical support to do so. You can use this programme to compare the performance of different cities, different regions and other districts in your countries that will attract more and more attention from public and we are sure that the information we are producing will be much widely used by the society. I know that there will be a small presentation on the outcome of this project that we have done in our Centre and Insha'Allah, we will start distributing the programme to you this year. This will be another contribution from our side to the Statistical Commission.

Although the Commission has been in the existence for a short time, a large amount of work has been achieved through your invaluable contributions. As you all know, we have established three working groups. The first working
