EDITORIAL

ver the last five years, Statistical Economic and Social Research and Training Centre for Islamic (SESRIC) has been Countries developing and implementing new and diversified technical cooperation and training initiatives and activities within its mandate. You can follow dedication to promoting

enhancing economic cooperation human capacity building in the member conducting countries through relevant training programmes and engaging technical cooperation activities with various national and international organizations throughout this new issue of Training E-Newsletter.

In this connection, the Vocational Education and Training Programme for OIC Member Countries (OIC-VET) emphasizes importance of coordination cooperation among all Member States to improve the quality of vocational education and training in the public and private sectors with the aim of supporting and enhancing the opportunities for individuals to develop their knowledge and skills and thus to contribute to the development and competitiveness of the economies of their countries. Since its official launch by H.E. Abdullah Gül, President of the Republic of Turkey and Chairman of COMCEC, during the COMCEC Economic Summit held in Istanbul on 9 November 2009, SESRIC, the Executive OIC Organ of the OIC-VET Programme, has worked towards the successful implementation of the various projects under the framework of OIC-VET Programme. To this end, I am very proud to say that, three successful pilot projects have already been accomplished and have become full-fledged programmes under the umbrella of OIC-VET.



In line with the recommendations adopted during the cooperation project in Ankara in May 2010, OIC- Occupational Safety and Health Network (OIC-OSHNET) has been kicked-off with a meeting, jointly organized by SESRIC and Turkish Centre for Occupational Health and Safety (ISGUM) on 16-17 May 2011, in Ankara Turkey, with the

participation of experts and directors of occupational safety and health, besides deputy secretaries of Ministries of Labour from 15 OIC Member Countries. SESRIC also started to work has on establishment of OIC-OSHNET Portal and experts' database and requested Member Countries to designate their National Focal Points for the OIC-OSHNET. Our aim is to turn this network into a platform for OSH professionals to exchange their practices and to share their experiences and projects in the field so that OIC Member Countries would enhance their capacities in this important area.

The second pilot project, in June 2010, has vielded to **ISMEK** Master Trainer Programme (IMTP), a joint programme between SESRIC and the Centre for Art and Vocational Training Courses of Istanbul Metropolitan Municipality (ISMEK) in 2011. In this context, ISMEK provides training courses to master trainers in various institutions in OIC Member Countries, under nine different categories. courses are planned within the framework of "Training of Trainers (ToT)", and open for participants who have field knowledge of at least intermediate level. First training project under the İMTP was implemented during the period 21 March - 1 April 2011 in İstanbul, Turkey. A group of ten master trainers from different provinces of the Republic of Pakistan were awarded MTP Certificate upon successful completion of the training courses in various categories.

As you may remember, successful pilot of OIC International implementation Student Internship Programme (OIC-ISIP), a special international internship programme operated under the International Business Forum (IBF), in the summer of 2010 and the award ceremony, where H.E Abdullah Gül, President of the Republic of Turkey, presented students their plaques. marked the start of the actual implementation phase. I am proud to let you know that the second group of students, who will develop their practical knowledge in the fields of medicine, engineering, finance. tourism. IT. media/communication and business, has started their internships in the summer of 2011.

In the meanwhile, Third Meeting of the Monitoring and Advisory Committee (MAC) of the Vocational Education and Training Programme for OIC Member Countries (OIC-VET) was organized by SESRIC in collaboration with Technical and Vocational Organization of the Islamic Training Republic of Iran (TVTO) on 17-18 July 2011, in Tehran. The meeting reviewed the progress since the last meeting adopted a set of recommendations that defines the ways and means collaboration within the scope of on-going and planned projects under the framework of OIC-VET Programme. In this connection, three thematic working groups on the subjects of "Virtual Training and Simulation", "Training of Trainers" and "Sharing of Best Practices in Vocational Education and Training" have been established recently. You may follow the activities of these working groups from the coming issues of this e-newsletter.

On the other hand, the Capacity Building Programme of SESRIC has been continuing to provide training to the professionals

in different fields of socioworking economic activity. Increasing participation institutions the relevant the impact Programme augments its and contributes significantly to the human capital development in the Member Countries. In this regard, I am happy to announce that activities under the Capacity Building Programme for Stock Exchanges in OIC Member Countries are about to begin. The responses to the related questionnaire have started to be collected and some training programmes for the last quarter of 2011 have already been planned.

As part of the technical cooperation activities and upon the request of 26th Session of COMCEC, SESRIC organised a workshop on "Impact of Transportation Networks on Trade and Tourism", the theme for the Exchange of Views at the 27th Session of the COMCEC in October 2011, in collaboration with Islamic Development Bank (IDB) and Ministry of Transport and Communication of the Republic of Turkey on 7-8 June 2011 in Izmir, Turkey. The workshop identified and examined the common obstacles challenges facing the OIC Member States in the area of transport and proposed possible ways and means of cooperation in this important field with a view enhancing intra-OIC trade and tourism.

Another important development during the past six months was the establishment of OIC E-Government Working Group. SESRIC successfully organized the first meeting of the Working Group on 5–6 July 2011 in Ankara, Republic of Turkey. The Working Group has discussed the main activities and roles as well as areas of cooperation and collaboration where it can act as a facilitator and catalyst for the benefit of egovernment systems of the OIC Member Countries.

Last but not least, SESRIC hosted the Third Meeting of the Joint Management Team

(JMT) of the Atlas Project in Istanbul, Turkey under the Chairmanship of OIC General Secretariat. The meeting was attended by the representatives of project partners, namely OIC, Royal Society, SESRIC, Qatar Foundation, British Council, OIC Standing Committee on Scientific and Technological Cooperation (COMSTECH), Nature and the Islamic Educational, Scientific and Cultural Organization (ISESCO). The main objective of the meeting was to review the status and progress of the project since the last JMT Meeting held in Istanbul on 3-4 October 2010, to examine lessons learned from the pilot phase of the project and devise appropriate methods to improve the process for further studies, as well as to collectively plan for the remainder of the project. It is decided that Indonesia, Iran, Kazakhstan, Nigeria and Senegal are the next tranche of countries, in addition to the on-going case studies of Pakistan, Egypt, Jordan and Qatar.

This issue of the Training E-Newsletter includes an article on the "State of Occupational Safety and Health in Pakistan" by Muhammad Javaid Iqbal, Central Labour Advisor at the Ministry of Labour and Manpower of the Islamic Republic of Pakistan. In addition, you would have a chance to know Technical and Vocational Training Organization of the Islamic Republic of Iran closer at the "Institution in Focus" section in this issue.





STATE OF OCCUPATIONAL HEALTH & SAFETY IN PAKISTAN

- a) The Factories Act, 1934,
- b) The Mine Act, 1923,
- c) The Road Transport Workers Ordinance, 1961,
- d) The West Pakistan Shops and Establishments Ordinance, 1969,
- e) The Dock Labourers Act, 1934,
- f) The Employment of Children Act, 1991.
- g) Workmen Compensation Act, 1923. Main health & safety provisions under these laws includes; cleanliness at



work in hazardous conditions etc. Supplementing these enactments rules are also framed to address occupational safety and health in certain specific occupations like, manufacturing and processing of lead, Aerated water, rubber, chromium, cellulose solution spraying, sand blasting, sodium, potassium, petrol gas generating plants etc. Following organizations are directly responsible for implementation of those provisions:

- a. Provincial Directorate of Labour Welfare
- b. Directorate of Dock Workers Safety
- c. Inspectorate of Mines at the provincial level
- d. Inspectorate of Boilers at the provincial level
- e. Centre for the Improvement of Working Conditions and Environment

Occupational safety and health has always been an area of concern for the national policy formulation. Labour Policy, 2011, Labour Inspection and protection Policies widely covered this subject and recommended for consolidation of law on safety and health, constitution of Tripartite National Safety & Health Council and effective implementation of the law.

Training and capacity building of the implementing machinery and other stake holders has always been a grey area in Pakistan. The only well-equipped center,

namely, Centre for the Improvement of Conditions Working & **Environment** (CIWC&E) located at Lahore is providing training, information and advisory services on safety, health and environment in Pakistan. The principal aim of this Centre is to combat the safety, health and working environment hazards in the industries in the province of Punjab, and to create awareness and change the attitudes of the employers/workers regarding safety, health and working environment. The Centre published its own newsletter, publicity material on safety and health, safety posters, safety leaflets, brochures and signs. Alongside providing on job and plant level training in the field of safety and health the Centre provides services of noise measurement, control of chemical hazards, selection and use of personal protective equipment, industrial hygiene, occupational disease control, machine safety, electrical Safety, ergonomics etc.

Occupational safety and health situation, in general, is criticized on the grounds that it

implementation lags. There are problems of limitation of scope and coverage. Evasion of laws also noted in the informal sector, home based industry and awareness mines. Lack of the stakeholders and incapacity of the inspection machinery are the common problems in Pakistan. There is a dire need of revolutionary steps in training and capacity building in this area. There are also possibilities of sharing expertise with the members of OIC. A first ever national training for the stakeholders occupational safety and health was organized in Pakistan with the collaboration of SESRIC, during April, 2011. The training was really useful. SESRIC, therefore, should extend its maximum support to explore further opportunities collaboration in the field of occupational safety and health, particularly, for the informal sector, mines and home based industries.

VOCATIONAL EDUCATION AND TRAINING PROGRAMME (OIC-VET)



The OIC Vocational Education and Training Programme (OIC-VET) for Member Countries is a programme prepared by the SESRIC in order to improve the quality of Vocational Education and Training (VET) in the public

and private sectors with the aim of supporting and enhancing the opportunities for individuals in the Member Countries to develop their knowledge and skills and thus to contribute to the development and competitiveness of the economies.

The Programme supports and supplements the activities of the Member Countries, while respecting the responsibility of the Member Countries for the content and implementation of vocational training. It aims at improving the competencies and skills of the people according to the needs and priorities of labour markets through intra-OIC partnerships at institutional level. The Programme focuses on increasing accessibility and raising the quality of VET, and provides an opportunity organizations involved in VET to build OIC partnerships, exchange best practices, increase the expertise of their staff and develop the skills and competencies of the participants. The Programme will cover the training areas included in the national in training programmes the Member Countries by introducing a transnational perspective in conformity with national priorities of the Member Countries.

OIC-VET Training Opportunities (TROP) Database Release

OIC Training Opportunities (TROP)
Database is an online platform of information where training institutions operating in the OIC
Member States can participate in the system and share their relevant

institutional and training information in order to generate further cooperation and collaboration initiatives among them. All related training institutions are given online access, by assigning them usernames & passwords to TROP system so that they are themselves be enabled to maintain, monitor and enhance information of their institutions and available training categories.

TROP is based on the realization that a more efficient and wider use of training facilities existing in the OIC Member States could be brought about by enabling individuals from certain States to



participate in the training conducted programmes by peer institutions in the other ones. SESRIC is interested in gathering information on training categories under which short-term courses,

workshops and/or seminars open to participants from the OIC Member States and designed for experienced staffs who aim at increasing their skills/knowledge in their areas of expertise.

TROP Database provides training institutions an opportunity to become a member of SESRIC Training Opportunities in order to ensure a more efficient and wider use of training facilities existing in the Member States. Iran Technical and Vocational Training Organization



Iran Technical and Vocational Training Organization (TVTO), which is affiliated to Ministry of Labor and

Social Affairs (MOLSA), was founded in 1980 by integrating three training bodies-MOLSA's General Directorate for Vocational Trainings, Apprenticeship Fund Apprenticeship Society - as Technical and Human Force Training Organization. In 1981 it was renamed as Technical and Vocational Training Organization. According to more than 10 related laws and 151 Articles of The Third Development Program and its confirmation in Fourth Development Program, TVTO is the main institution in charge of short-term Technical Vocational Trainings. It is also the Head of Special Committee on non-formal Technical and Vocational Training with 16 members from various ministries, organizations; employee & employer associations. TVTO implements its trainings through both public and private sectors.

TVTO's main task is to provide vocational training and research courses at permanent centers of the public sector (600 centersnationwide), besides mobile training teams (in remote areas), training in prisons, training in garrisons, training in industries, training in Instructor Training Center (ITC) and private training institutions (fourteen thousand institutions authorized by TVTO). TVTO trains skilled and semi-skilled labor force which is needed by industry. agriculture and service providers throughout the country, and improves the culture of getting technical skills in the society.

TVTO has continuously developed communication with international Institutes like International Labor Organization (ILO) and World Skills International (WSI), to achieve the latest sciences and technologies and keep with pace international standards.

Research, as one of the main tasks of TVTO. deals with major challenges between training and labor market and industries. Through research, TVTO tries to deeply understand the industries and the skills they need, collect the information required for skills training curriculum development, training software hardware, training aid; and study the existing training systems in other local and global institutions, study and suggest the labor force replacement trend, upgrade the workers' skills and set up unions for technical and vocational trainers to attract their participation.

Main strategies of the institution are skills training, based on costumer's need and request (demand-based); maximum privatization of skills training – delivering the skills training to non- governmental individuals and entities; and using all local and international capacities and experiences efficiently.

Target community of the institution consists of employees (nearly 21 million nation-wide), university students and graduates (2.5 million nation-wide), and urban and rural job seekers (3 million nation-wide).
