We believe that through close cooperation and networking among member countries, the OIC-VET Programme will establish a larger community of beneficiaries. Our ultimate desire is that all OIC Member Countries could benefit from this significant Programme which could in fact be realised by the implementation of the objectives of this significant programme.

As you may recall the OIC-VET Programme was launched by Abdullah Gül, President of the Republic of Turkey and Chairman of COMCEC during the COMCEC Economic Summit held in Istanbul on 9 November 2009 with the participation of the heads of states and governments. It is indeed noteworthy that in the same Summit, H.E. Gül, articulated his belief towards the vision of this Programme to improve the quality of human capital resources and realise socio-economic development in OIC Member Countries, and called upon OIC Member Countries to support and actively participate in the Programme. various sectors of the economy. Therefore, the OIC-VET Programme not only serves as a platform for enhancing human resources of the OIC Member Countries but also a channel for strengthening the education and social network in our countries. I would like to take this opportunity to inform that the OIC-VET Partners Database, which has been developed with the aim of providing information on potential partners who are able and keen to effectively participate in project implementations within the framework of the OIC-VET Programme, will be instrumental for promoting necessary cooperation among NFPs during the implementation of the OIC-VET Programme as well as draw a new direction in promoting their activities in this field.

Therefore, it is indeed heartening that representatives of National Focal Points of the OIC-VET Programme and the concerned OIC organs are participating in this meeting to discuss key issues regarding vocational education and training. It is my hope that open and inclusive dialogue will be the hallmark of this meeting and its concrete outcome will provide guidance for more coordinated action.

I am confident that the work you are about to accomplish would, ultimately, approximate and contribute significantly to the collective welfare for the Islamic Ummah. As we all look forward to the successful outcome of this meeting, I wish you all the success in your deliberations.
