It gives me a great honour and privilege, on behalf of the Islamic Development Bank (IDB), to express our thanks and appreciation to SESRIC for hosting this important First Session of the OIC Statistical Commission (SC) in this great city of Istanbul, Turkey.

In today's world, demand for quality statistics on indicators of countries worldwide for the purpose of monitoring the performance and progress of development goals and initiatives has increased considerably. Unfortunately, the National Statistical Offices (NSOs) which are expected to supply the quality statistics are at different levels of development with diverse challenges which vary from country to country.

At OIC level, several efforts have been made to bring NSOs together and address the challenges facing them especially in the area of data collection, data processing and data dissemination. In our view, there is urgent need to have an apex statistical body in which statistical-related issues unique to OIC member countries can be discussed and Dr. Bello's Speech—First OIC SC

decision taken vis-a-vis international standards. Accordingly, we believe that

the establishment of OIC-Statistical Commission (OIC-StatCom) is long

overdue for many reasons. First, OIC member countries together form the 2nd

largest organisation in the world after the United Nations making it necessary

to have a platform for discussing critical issues pertaining to all aspects of

statistics. Second, the Commission will enable member countries to exchange

ideas and knowledge, share best practices, and coordinate statistical activities at

OIC level.

IDB welcomes the establishment of the OIC-StatCom and looks forward to it

becoming the highest decision-making body for overseeing and setting

direction for OIC-level statistical activities. We call on NSOs of OIC member

countries as well as OIC institutions to work together and make it a reality.

It is our hope that in the next 2 days, we would be able to define the goals,

objectives and modus operandi of the OIC-StatCom as well as establish various

working groups to focus on different sectors and themes relevant to OIC

initiatives such as Trade, Poverty, Climate Change, Zakat, Awqaf, Islamic

banks and financial institutions including Microfinance Institutions etc..
